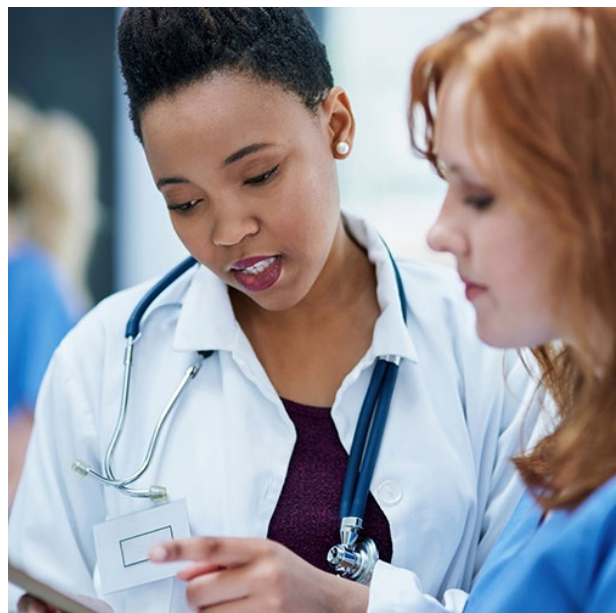

- Direct, nurse-led healthcare services

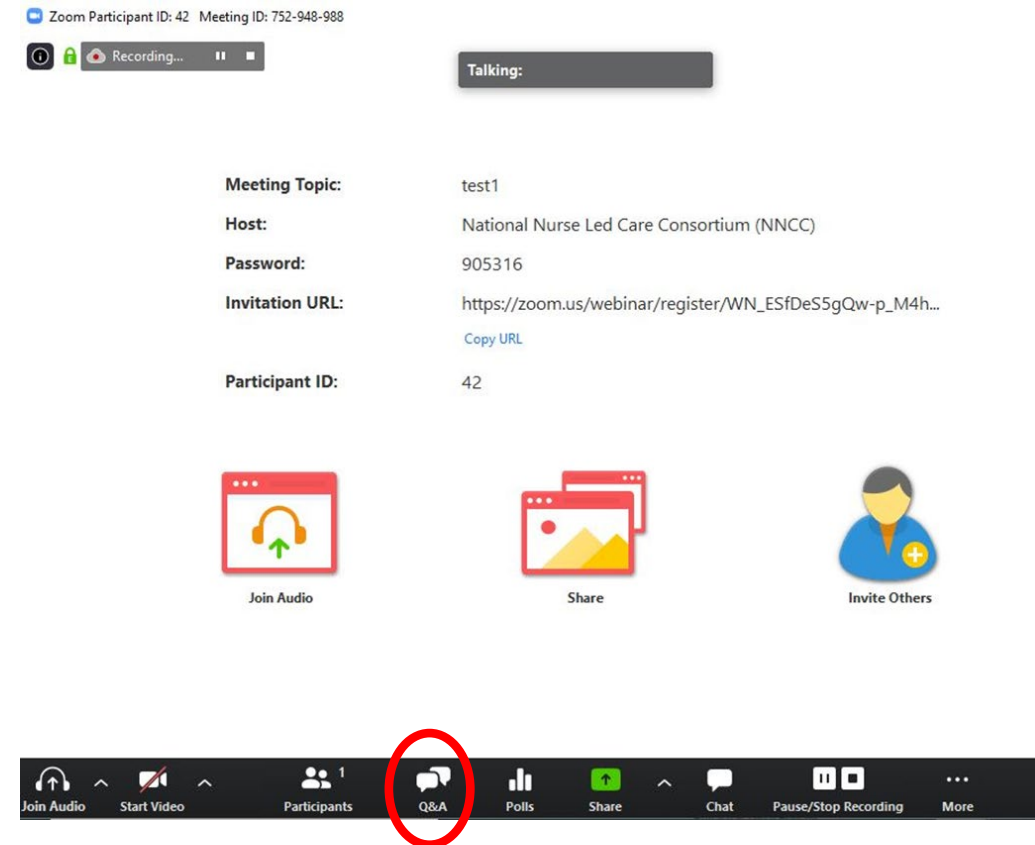

Objectives

1. Define disability (intellectual/developmental).

What is the Definition of Disability?

The American Disability Act defines disability as a physical or mental impairment that substantially limits one or more major life activities, a person who has a history or record of such an impairment, or a person who is perceived by others as having such an impairment.

(ADA, 2011)

Intellectual Disability

Characterized by significant limitations in both intellectual functioning and in adaptive behavior as expressed in conceptual, social and practical adaptive skills.

Originates in the developmental period which is defined operationally as before the age of 22.

(Schalock, Lukasson, Tassè, 2021)

Developmental Disability

Severe, chronic disability of an individual who has a mental or physical impairment by age 22. Likely to continue indefinitely and results in substantial functional limitations in three or more areas of major life activity.

(Developmental Disabilities Act, 2000)

Who are the People with Disabilities?

An estimated 7.37 million people in the United States has some form of intellectual or developmental disability in 2016.

70% of individuals with I/DD live with a family caregiver.

16% of individuals with I/DD live alone.

14% live in supervised residential setting.

22% participated in the labor force.

American Nurses Association (ANA) Position Statement: Nurse's Role in Providing Ethically and Developmentally Appropriate Care to People With Intellectual and Developmental Disabilities

The American Nurses Association believes that nurses must provide compassionate, comprehensive, and person-centered care to all people, inclusive of at-risk populations such as IDD who experience health disparities across practice settings.

The nurse's primary commitment is to the patient, whether an individual, family, group, community or population. Nurses are well positioned to advocate for the rights of people with IDD.

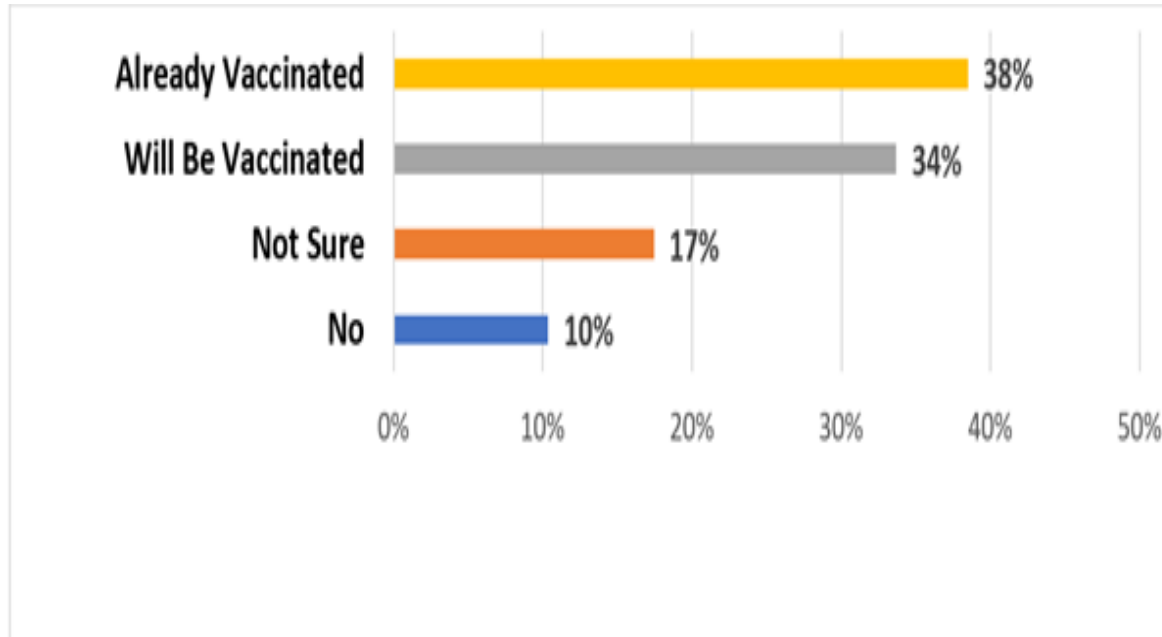

The Devastating Impact of Covid-19 on Individuals with Intellectual Disabilities in the United States. A study across 547 U.S. health care organizations finds that individuals with intellectual disabilities are at substantially increased risk of dying from Covid-19.

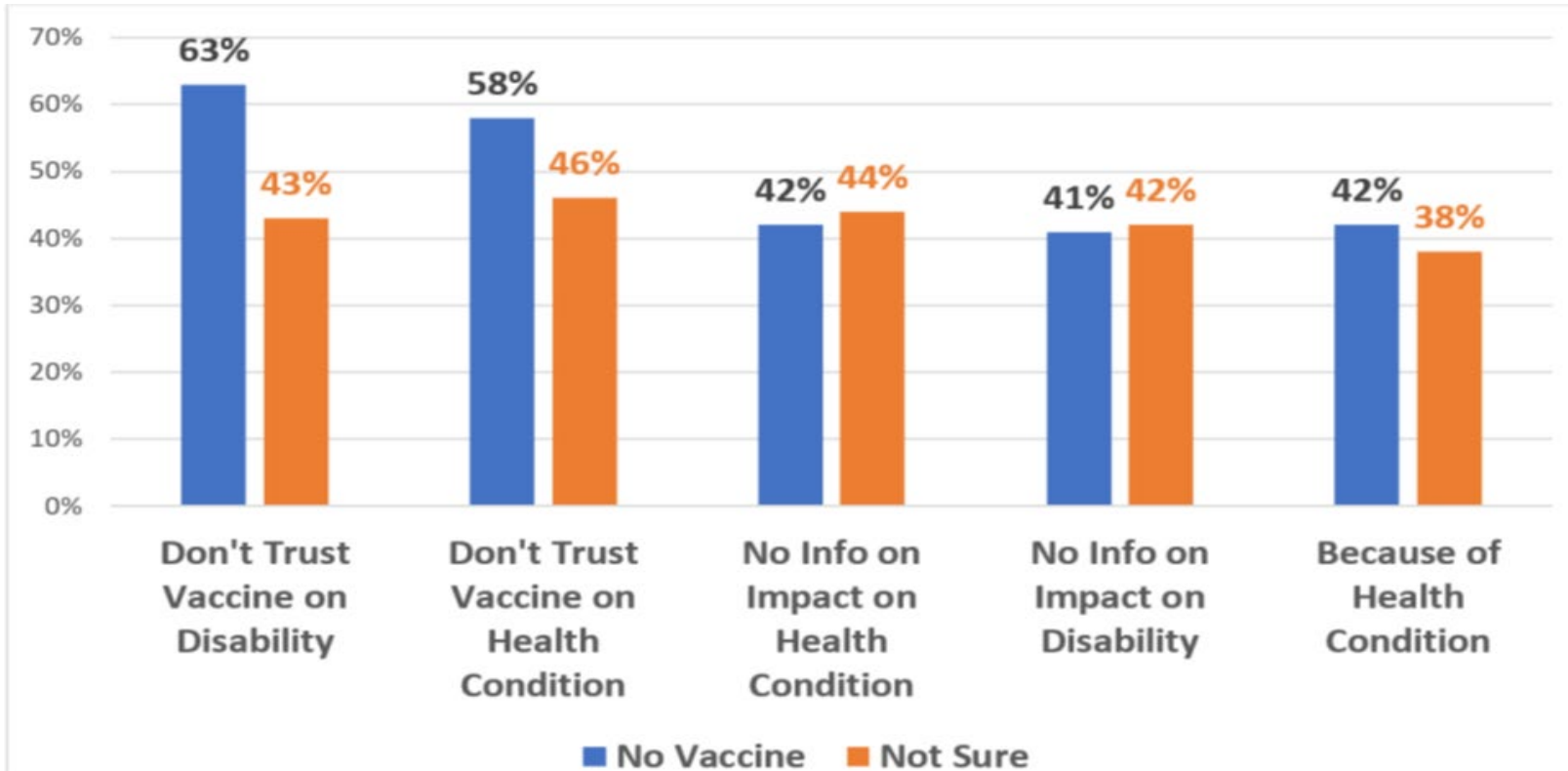
Survey Results: American Association on Health and Disability (AAHD)

COVID-19 Vaccine Education

People with disabilities, particularly people with disabilities in communities of color, often have questions and concerns surrounding COVID-19 vaccination; some of these individuals may be hesitant or fearful of receiving a vaccine as the result of discrimination or medical mistreatment they have experienced in the past.

Targeted Approaches

- Identify organizations in your state that support persons with disabilities.
- Assess your state COVID-19 rollout plan for clear messaging; identify phases/categories as ID/DD instead of “individuals with high-risk conditions”.
- Determine how state plans classify congregate facilities, intermediate care facilities.
- Assess state rollout plans for accessible locations (centrally located) that can be reached by mass transit; vaccine at home programs should be a consideration.
- Model other states with successful rollout plans.
- Ensure websites and apps are 508-compliant and accessible to persons with various accommodation needs (using assistive technology and screen readers).
- Develop a plan to spread the word of your advocacy efforts, proposals and concerns.

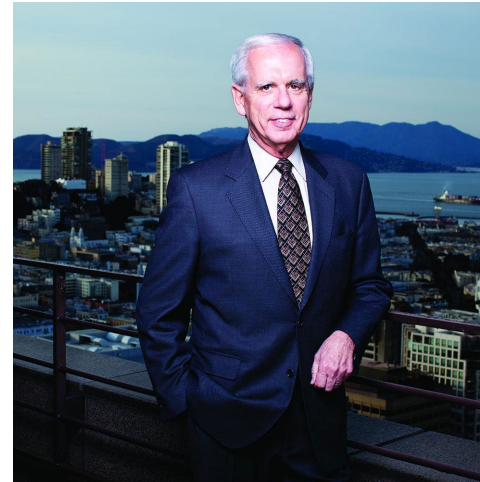
