

#### People at Higher Risk and Special Populations

#### High Risk Groups

Older people and people of all ages with severe underlying health conditions — like heart disease, lung disease and diabetes, for example — seem to be at higher risk of developing serious COVID-19 illness.



People at Higher Risk for Serious Illness from COVID-19

#### **Special Populations**

CDC has information for other special population, who at this time are not considered high risk of developing serious COVID-19 illness, but are at increased risk of severe illness from other infectious diseases. These include pregnant women and children.

#### Goals during pandemic

- "Flatten the curve"
  - No intervention, infection rate doubles weekly
  - Target: "flatten" to a doubling over 8 weeks
- 4 strategic components
  - Containment
  - Identify illness early
  - Minimize additional exposures
  - Control anxiety

#### High Risk Populations

- Elderly
- Co-morbid diseases
- Low socio-economic status
- Front-line workers

#### Successful Practices – 4 areas of focus

- Community Resource Engagement
- Housing
- Phones
- PPE

#### Community Resource Engagement

- Hospitals
  - Emergency Departments
- Primary Care Providers
  - FQHC's/Specialists
- Law Enforcement
- EMS
- Existing Caretakers
- Federal/State Agencies
  - Public Health Depts

- Jails
- Chemical Dependency
- Behavioral Health Centers
- Therapeutic Courts
- Housing Authorities
- Protective Services
- Employment Services
- Shelters

#### Housing Options

- Existing Buildings
  - Reverse Isolation
- Field Tents
  - 3 levels
    - Identified patients
    - Symptomatic; not yet diagnosed
    - Exposed; not yet symptomatic
- Coordination
  - Shelters/Hospitals/Public Health Toileting/Cleaning/Flow/Monitoring

#### Phones

- Get phones to patients
- Increase interactions
  - Daily check ins
  - Providers available at target hours
  - Message anxiety
- Facetime/Skype
  - Send pictures (cellulitis/abscess)
  - Listen
  - Billing

## Personal Protective Equipment (PPE)

- Wear during testing
- Re-use of PPE
  - <u>CDC Guidelines for Extended Use and Limited</u> Reuse of PPE
- Alternate devices
  - CDC Strategies for optimizing PPE

#### Additional Thoughts

- Staff re-assignments
- Sanitation
- Mental health tips
- MAT
- · Pharmaceutical shortages

#### Furloughed and non-essential staff

- Easily re-assigned duties
  - Phone calls
  - Packaging homeless kits
    - Soaps/Hand Sanitizers/Wipes/Gloves/Ensure/TP
- Collaborating with local organizations
  - Community Service Stations
  - Meal delivery
    - Access to meals currently limited
  - Street Medicine
  - Transportation

#### Sanitation

- Establish these homeless resources early:
  - Public hand sanitation stations
  - Public outhouses
  - Public showers
- Education for shelter staff
  - Correct sanitation practices
  - Coordinate with Public Health/Hospital ID

#### Mental Health Tips

- 25% increase in psychotic breaks
- Mitigate anxiety
  - · Emphasize the good work being done
  - · Involve Pastoral Care and BH staff early
  - · Create standard messaging around facts
  - Remind patients: services will be slower
  - Patience
- Coordinate "shelter talks"

#### MAT

- Consider increasing Rx intervals
  - Doubling intervals
  - Comes with some risk
- Consider Sublocade
  - Injectable buprenorphine XR
- Establish Mobile Treatment Vans
- Maintain strong Narcan efforts
- Consider Telemedicine

#### Pharmaceuticals

- Albuterol in short supply
  - Used by homeless frequently
  - · Consider Levoalbuterol
- Anticipate other pharmaceuticals shortages
  - Buprenorphine
  - Narcan
  - Antibiotics



## Licensure/Scope of Practice Considerations "Waiving State Licensing Restrictions for Telehealth Helps Combat COVID-19" - ATA

- Provide more flexibility on:
  - Advanced practice provider supervision
  - The type of telehealth modalities and technologies providers can use
  - Specific technologies to establish a patient provider relationship for diagnosis and treatment recommendations, so long as the standard of care is met

## Licensure/Scope of Practice Considerations "Waiving State Licensing Restrictions for Telehealth Helps Combat COVID-19" - ATA

- Waive licensure regulations for qualified out-ofstate clinicians in good standing
- Waive licensure requirements for clinicians to obtain special approval during the emergency

#### **Patient Informed Consent**

- Content of Informed Consent
  - Specificity and Frequency
  - Telehealth vs. In-Person Visit
  - Prescribing Policies
  - Privacy and Security Considerations

#### **Professional Liability Considerations**

- Evaluation of Professional Liability Insurance Policy (and/or FTCA Requirements/Gap Policy)
  - Telehealth vs. Face to Face
  - State Licensure
  - Employees vs. Contractors vs. Volunteers

#### **Professional Liability Considerations**

- Purposes of telehealth visits (e.g., acuity level)
- Informed consent
- Training for providers
- Documentation in medical record

#### **Privacy and Security Considerations**

- Evaluating technology and equipment options
- Including telehealth in the covered entity's security risk analysis
- Ensuring execution of business associate agreements
- Developing policies and procedures
- Training of staff members
- Notifying patients

#### **Privacy and Security Considerations**

On March 17<sup>th</sup>, OCR announced that it **will not impose penalties** against covered health care providers for the lack of a business associate agreement with any **non-public facing remote communication product** or any other non-compliance with the HIPAA Rules that relates to the **good faith** provision of **telehealth services during the COVID-19 nationwide public health emergency**.

#### **Privacy and Security Considerations**

Non-public facing remote communication products:

- As a default, allow only the intended parties to participate in the communication
- Employ end-to-end encryption
- Support individual user accounts, logins and passcodes
- Allow some degree of control over video or audio capabilities

### **Privacy and Security Considerations**

Non-public facing remote communication platforms that **may be used** include:

- Apple FaceTime
- Facebook Messenger video chat
- Google Hangouts video
- Whatsapp video chat
- Skype

And texting applications such as:

- Signal
- Jabber
- Facebook Messenger
- Google Hangouts
- Whatsapp
- iMessage

### **Privacy and Security Considerations**

Public facing video communication products are designed to be open to the public or allow wide or indiscriminate access to the communication.

Public facing products that **should not be used** to provide telehealth services include:

- Facebook Live
- Twitch
- TikTok
- Other similar public facing remote communication products (chat rooms like Slack)

### **Privacy and Security Considerations**

Applies to telehealth provided for any reason, including:

- Diagnosis and treatment of health conditions related to COVID-19
- Sprained ankle
- Dental consultation
- Psychological evaluation
- Review of physical therapy practices
- Adjustment of prescriptions
- Mental health counseling

<sup>\*</sup> Does not apply to records protected by 42 CFR Part 2.

### **Privacy and Security Considerations**

OCR encourages covered entities to:

- Notify patients of the potential privacy risks associated with use of third-party applications
- Enable all available encryption and privacy modes when using such applications
- Use a private location to provide telehealth; encourage patients to use a private location to receive telehealth services

### **Privacy and Security Considerations**

Once OCR re-starts enforcement related to telehealth, consider whether your covered entity will:

- 1. Continue to use telehealth by executing business associate agreements with individual platforms and applications
- 2. Consolidate telehealth offerings with one vendor, platform or application
- 3. Limit use of telehealth to certain services
- Discontinue telehealth
