






Covid-19 Response Challenges






Covid-19 Emergency State Licensure

Covid-19 Practice Challenges

"It is easier for me to go serve in another state than it is for me to volunteer in my own community."



"I've been sidelined. My clinic is closed, and I can't get a physician for a collaborative agreement to provide telehealth or work in another capacity."



Moving Forward The Rule of 5's—action steps to take this year!

- Attend a "Meet the Candidate" and "Open House"
- Donate time and money to support a candidate that is running for office
- Write a note of congratulations to the candidate that wins and offer to serve as a consult on health issues or other areas where you have expertise.
- Send a "thank you" letter to your elected representative when they vote in support of a non-healthcare issue that 's important to you.
- Forward a copy of a news article on a healthcare interest





Expanding the role of Advanced Practice Clinicians: *A Strategic Priority*

- Open Door has a long history of having physicians, nurse practitioners, and physician assistants working side by side, managing their own panels of patients.
- Widespread camaraderie, built over years, has contributed to mutual respect and confidence in one another's capabilities and strengths.
- Open Door has a strong interdisciplinary care team model with interdisciplinary collaboration, though emphasis has not been on a unique role for APCs or collaboration between APCs and MDs



Benefits of the Care Team Model:

- Clinician Recruitment
- Clinician Satisfaction
- Patient Access to Care
- Patient Satisfaction

Pathway for Success

- Onboarding approach → Possible future fellowship/residency
- Culture of mutual respect and collaboration
- Structured Model of Collaboration
- Specific roles for APCs that utilize their strengths

My role at Open Door: A Unique NP Opportunity

- Hybrid primary care clinician/administrator
- Report to the Community Health Department
- Practice Transformation champion role
 - Care Team Innovation
 - Value-Based Care Initiatives
 - Transitions of Care
 - Telehealth Model of Care

An NP-led Covid Response

- **Mid March:** Sudden influx in patient calls/inquiries
- Rapidly developed NP-led Covid Triage protocol
 - 3 NPs (me, School-Based Health, Community Health Nurse)
 - Soon a group of MDs joined in
- Quickly transitioned to billable telehealth
- Scaled to all PCPs

APCs in the Post-Covid Emergency Era


- Care Teams will need to adapt to a new consumer appetite and logistical need for virtual care
- Exploring unique role for NPs in telehealth
 - Covid testing/engagement
 - Virtual Care role on care team
 - Transitions of Care
 - School-Based Care
 - Others . . .
