## WHO WE ARE

The National Nurse-Led Care Consortium (NNCC) is a national member-supported organization advocating on behalf of nurse leaders on the frontlines of health care. AmeriCorps members help our organization fulfill its mission by supporting public health programming and facilitating organizational development. AmeriCorps state grants support the efforts of organizations to recruit and deploy members to address unmet needs of communities they serve.

## OPPORTUNITY FOR PARTNERSHIP

NNCC is applying for an AmeriCorps State Program grant. We are seeking health centers and organizations throughout Pennsylvania to participate as host sites for our AmeriCorps members. The Corporation for National and Community Service (CNCS) considers the opioid epidemic a high priority for service work. Organizations can leverage AmeriCorps members to build outreach and education programs targeted at combating the opioid crisis.

As a sponsor, NNCC provides oversight and support for organizations interested in hosting AmeriCorps members at their sites to address their communities' needs. NNCC is responsible for AmeriCorps program application submission, AmeriCorps candidate recruitment, AmeriCorps member training, site supervisor support and completion of financial and reporting requirements. The cost for the health center or organization to host an AmeriCorps member is \$15,000 per member for the entire year of service.

## HOW AMERICORPS MEMBERS CAN HELP YOU

- Maximize coordination of health center and COE resources
- Coordinate with community organizations to engage individuals impacted by the opioid crisis
- Strengthen existing health center programs to expand resources to include opioid prevention
- Develop strategies for sustainable partnerships throughout the designated county in Pennsylvania
- Conduct outreach for at-risk individuals and their network
- Provide educational workshops to community members and family circles
- Maintain data for case management of patients to sustain programming during this crisis

**June 2019**

CNCS awards AmeriCorps State Programs

**July - Sept 2019**

NNCC and health centers recruit and place AmeriCorps members
