



## **RIGHT TO SMOKE?**

There is no Constitutional "right" to smoke in your apartment.

Tobacco users are not a "protected group."



## 12 HELPING TOBACCO USERS QUIT

60-80% of Tobacco Users Report a Desire to Quit!

Smoke-free Policy can help nudge many people to make the change!



### HOUSING-RELATED TOBACCO CONTROL PRIORITIES

### I. Communicate, Adopt, Enforce Smoke-Free Policies

- I) Public housing authorities (PHAS)
- 2) Private housing
- 3) Funders of affordable housing (example PHFA)
- 4) Providers of housing for disparately impacted and special need populations



### HOUSING-RELATED TOBACCO CONTROL PRIORITIES

### II. Provide on-site Tobacco Dependence Treatment

- -Quit Coaching, and Nicotine Replacement (patches) – No Cost
- Referrals to I-800 QUIT NOW or online at pa.quitlogix.org



### 15 PARTNERSHIP WITH PA HOUSING FINANCE AGENCY

- New "smoke-free" requirement for all new rental housing in their 2017-18 Low Income Housing Tax Credit (LIHTC) program. - Thanks to SEPA Tobacco-Free MUH Team and PHFA!
- PHFA also sent a letter to owners and managers of all *existing* multi-family projects to encourage them to go smoke free, and informing them of the policy and technical assistance available.


# IMPLICATIONS OF HUD RULE

- Q: What types of tobacco products does the rule include?
- A: The rule prohibits the use of "prohibited tobacco products," which are defined as both "waterpipes (hookahs)" and "items that involve the ignition and burning of tobacco leaves, such as (but not limited to) cigarettes, cigars, and pipes." While the rule does not include electronic cigarettes (e-cigarettes) or other electronic smoking devices, PHAs can choose to prohibit the use of e-cigarettes in their smoke-free policies

# IMPLICATIONS OF HUD RULE

 Q: What units of public housing does the rule cover? A: The rule covers public housing units, including scattered site and single-family properties. The rule excludes dwelling units in mixed-finance projects and does not apply to housing assisted under Section 8, PHA properties that have converted to project-based rental assistance contracts under the Rental Assistance Demonstration Program, or tribal housing. HUD continues to encourage excluded properties to voluntarily adopt smoke-free policies.



### 22 KEY TO SUCCESS #1: INVOLVE <u>ALL</u> STAFF

- In development of policy, rationale, language
- In messaging the new policy to tenants
  - Positive, empathetic, non-punitive (see guide for examples of positive language)
- Staff training is critical!
- \*Case study: Federation Housing



### 23 KEY TO SUCCESS #2: INCLUDE <u>RESIDENTS</u> IN THE PROCESS AS EARLY AS POSSIBLE

- Help residents to feel that they have had some input in policy development
- Give residents an opportunity to vent
- Give residents an opportunity to express support for the policy
- Schedule one or more meetings depending on size of the apartment community

### 24 KEY TO SUCCESS #3: IMPLEMENT THE POLICY THOUGHTFULLY

#### • Essential Policy Elements

- Tiered warning system including the opportunity to participate in tobacco dependence treatment programs
- Must apply to everyone including visitors, staff and contract workers
- Define "smoking", areas outside where smoking may be permitted



### 25 KEY TO SUCCESS #3: IMPLEMENT THE POLICY THOUGHTFULLY


- Develop a systematic approach for documenting violations
  - No favorites or looking the other way!
  - The Enforcement Guide includes a systematic approach for how to document violations
  - A model policy is included in the guide
- Eviction is not the goal.
- Provide opportunities and resources to assist in quitting smoking can help residents accept and comply with policy changes.

### 26 DISTRICT JUDGES

 The Enforcement Guide includes talking points with District Justices (if all else fails and

eviction becomes the only option).

 Proven to be very useful in prevailing before the court.



### 27 TOBACCO CONTROL OPPORTUNITIES

- EHR integration (connect clinics to Quitline, get usage data back, HIPAA secure)
- Performance Metrics (screening rates, diagnostic codes, treatment plans %, % with Rx, % filled Rx, care coordination)
- Certified Tobacco Treatment Specialist Training Programs
- Staff Trainings: Resources (i.e. what is the quit line?) and treatment best-practices (i.e. how is the nicotine gum supposed to be used)
- Need for Champion is key! pivot to Izzy and Karla
